(II) INTRODUCTION

In accordance with the order No. 74-22-OD dated on March 25, 2022 of the General Director of the National Institution "Independent Accreditation and Rating Agency" from May 31 to June 2, 2022, an external expert commission assessed the quality of educational programs as 7M02161 Art management, 7M02154 Film and TV directing for compliance with the standards of primary specialized accreditation of educational programs of organizations of higher and (or) postgraduate education (Ex-ante) of the IAAR (Order No. 68-18 / 1-OD dated on May 25, 2018).

The report of the external expert commission (EEC) contains an assessment of educational programs 7M02161 Art management, 7M02154 Film and TV directing to the IAAR criteria, recommendations of the EEC for further improvement of the educational program and profile parameters of educational programs.

(III) REPRESENTATION OF THE EDUCATIONAL ORGANIZATION

T.K. Zhurgenov Kazakh National Academy of Arts was organized in 1978 as Alma-Ata State Theater and Art Institute. Statistics on assessed EPs until May 1, 2022.

In accordance with the Decree of the Government of the Republic of Kazakhstan No. 236 dated February 14, 2000, on the basis of the former T.K. Zhurgenov Kazakh State Institute of Theater and Cinema and T.K. Zhurgenov Kazakh State Art Academy, Kazakh State Academy of Arts, according to the Decree of the President of the Republic of Kazakhstan No. 648 dated July 5, 2001 "On granting a special status to certain state higher educational institutions", the academy was given a special status "T.K. Zhurgenov Kazakh National Academy of Arts.

For the first time in Kazakhstan in T.K. Zhurgenov KazNAA, Doctorate (PhD) was opened in 7 educational art programs (2009). Thanks to the study of international experience in the training of art specialists, the academy has opened a scientific and practical center for postgraduate education, scientific and creative laboratories, as well as a Dissertation Council for the defense of dissertations in art specialties.

A department for advanced training and retraining of personnel was opened in 2008.

The Academy has six faculties: 1) Theatrical art 2) Film and TV; 3) Choreography; 4) Painting, sculpture and design; 5) Art history; 6) Musical art. Training of specialists is carried out by 23 departments, of which 17 are graduating, 6 general academic. These structural units provide a multi-level educational process. Training of bachelors, masters and doctoral students in all EPs is carried out on the basis of license No. KZ71LAA00005325 dated July 14, 2015, issued by the Committee for Control in Education and Science of the Ministry of Education and Science of the Republic of Kazakhstan dated February 3, 2010 No. 0137419 (https://cloud.mail.ru/public/NSom/sQ965HAEh).

T.K. Zhurgenov KazNAA has 2 educational buildings, a boarding school, a hostel, a sports ground, a library. The total area of buildings and structures of the academy, according to the available technical passports, is 24828.3 m2. Both buildings of the academy comply with sanitary standards and fire safety requirements.

The implementation of the accredited educational programs 7M02154 Film and TV Directing and 7M02161 Art Management is carried out by the graduating departments of Directing Screen Arts and Art Management and Producing, respectively.

The Department of Art Management and Producing, which is involved in the training of specialists in EP 7M02161 Art Management, currently employs only 9 people, of which 100% are full-time teachers. The degree of the total number of teaching staff for EP is 66.6%. The educational process under the program is provided by a highly qualified teaching staff, including 4 candidates of economic sciences, 1 doctor of PhD, 1 professor, 2 masters. The average age of the teaching staff in the department is 47 years.

As part of the Department of Directing Screen Arts in the 2021-2022 academic year, there are 32 teaching staff, 27 people in the staff, 5 part-time people, the percentage of degrees is 40%, of which: Doctors of Science - 1, PhD - 4, Honored Workers of the Republic of Kazakhstan - 7, masters of science - 8, with government awards - 3 people. The average age of the teaching staff in the department is 44 years. The quality of the teaching staff in the direction of the EP

Educational programs 7M02161 Art Management, 7M02154 Film and TV Directing are preparing undergraduates in the profile direction with the award of a Master of Arts degree. The contingent of undergraduates in the educational program 7M02161 Art Management is 7 people, including under the state order - no, according to EP 7M02154 Film and TV Directing - 1 person.

The volume of the library fund of the university EP 7M02161 Art Management as of December 1, 2021 on physical (material) media is 256983 copies (116415 titles), of which educational publications - 162720 copies, scientific publications - 5624 copies. By subscription, the library has 89 (330 copies) titles of newspapers and magazines.

(IV) DESCRIPTION OF THE PREVIOUS ACCREDITATION PROCEDURE

Educational programs 7M02154 Film and TV Directing and 7M02161 Art Management RSI "T.K. Zhurgenov Kazakh National Academy of Arts" of the MCS RK, an external assessment for compliance with the standards of primary specialized accreditation of educational programs of organizations of higher and (or) postgraduate education (Ex-ante) of the IAAR (Order No. 68-18 / 1-OD dated May 25, 2018) is being held for the first time.

(V) DESCRIPTION OF THE EEC VISIT

The work of the EEC was carried out on the basis of the Visit Program using a hybrid model of an expert commission for specialized and primary specialized accreditation of educational programs ...

In order to coordinate the work of the EEC, a kick-off meeting was held on May 17, 2022, during which powers were distributed among the members of the commission, the schedule of the visit was specified, and agreement was reached on the choice of examination methods.

To obtain objective information about the quality of educational programs and the entire infrastructure of the university, to clarify the content of self-assessment reports, on-line meetings were held with the rector, vice-rectors of the university in areas of activity, heads of structural divisions, heads of educational programs, heads of departments, representatives of teaching staff, students, graduates (for EPs with graduates), employers. A total of 30 representatives took part in the meetings.

During the off-line visit and watching videos, the members of the EEC got acquainted with the state of the material and technical base.

At the meetings of the EEC IAAR in a hybrid format with the target groups of the university, the mechanisms for implementing the policy of the university were clarified and certain data presented in the self-assessment report of the university were specified.

Members of the EEC in a hybrid format visited the bases of practices assessed by the EP: JSC Sh. Aimanova Kazakhfilm.

(VI) COMPLIANCE WITH PRIMARY SPECIALIZED ACCREDITATION (EX-ANTE) STANDARDS

6.1. Standard "Management of the educational program"

- The management of the EP must demonstrate the existence of an internal quality assurance system for the EP, including its design, management and monitoring, their improvement, decision-making based on facts.

Evidence

Activities of T. K. Zhurgenov KazNAA is carried out in accordance with the Development Strategy of T.K. Zhurgenov Kazakh National Academy of Arts for 2016 - 2026, (Minutes of the Academic Council No. 10 dated May 26, 2016), aimed at the formation of competitive specialists in Kazakhstan, based on the integration of education, science and production.

The procedure for organizing the educational process at the academy for programs of higher and postgraduate education is regulated by the Academic Quality Policy, approved by the decision of the Academic Council of October 29, 2020, protocol No. 3, whichreflects the requirements for the quality of the organization of the educational process.

This document is part of the strategic management and is considered together with other documents, the most important of which is the Quality Policy, approved by the decision of the Academic Council of August 27, 2021, Protocol No. 1. It is aimed at the consistent and continuous improvement of all processes implemented by the Academy and the achievement of compliance with national and international standards. To implement the quality assurance policy, changes were made to the organizational structure of the academy based on the recommendations of the EEC.

The policy is implemented through processes and standards for internal quality assurance, which involve the participation of all departments of the university. The policy has an official status and is available to the general public on the website. T. K. Zhurgenova KazNAAwww.kaznai.kz.

The quality of educational services provided by T.K. Zhurgenov KazNAA and it is systematically confirmed by the results of external procedures for assessing the quality of educational programs. In 2010, 2013, 2018, the Independent Accreditation and Rating Agency of the Republic of Kazakhstan conducted institutional accreditation. The Academy is accredited for a period of 5 years.

There is a system for monitoring the quality of preparation of educational and methodological documentation, including the content of educational programs at T.K. Zhurgenov KazNAA. To monitor the implementation of the educational program and as emerging problems are identified, including those related to resource provision, the following documents are approved and updated at the faculties and departments:

- Regulations on the final certification of students of the RSU T.K. Zhurgenov KazNAA MCS RK-24.12.2020, No. 5, Ed. No. 2;
- Regulations on the ongoing monitoring of progress and intermediate certification of students of the RSU T.K. Zhurgenov KazNAA MCS RK-28.08.2020, No. 1;
 - Regulations on the organization of the educational process with the use of DOT;
 - Rules for admission to magistracy and PhD Doctoral studies;
- Regulations on the passage of professional practice for students of postgraduate education T.K. Zhurgenov KazNAA, etc.

At the university level, the collegiate bodies that consider the development of educational programs are the Academic Council and the Educational and Methodological Council. Academic Council consists of 43 members - rector, vice-rectors, deans of faculties, heads of structural divisions, representatives of the faculty, student and public organizations of the university (Academic Council-23.11.2021.pdf (kaznai.kz).

Implementation of educational programs 7M02161 Art management, 7M02154 Film and TV directing is determined by the development plan. The goals of the programs are posted on the website of T.K. Zhurgenov KazNAA, in the classrooms of the department "Art Management and Producing", "Direction of Screen Arts".(https://cloud.mail.ru/public/PzjD/6i2uzjo1D).

Analytical part

EEC IAAR Mechanism for strategic planning for the development of accredited educational programs 7M02161 Art management, 7M02154 Film and TV directing is provided through the Development Strategy of T.K. Zhurgenov Kazakh National Academy of Arts for 2016 - 2026, as well as Strategic plans for the development of faculties, plans for the development of educational programs, comprehensive work plans for faculties and annual work plans for graduating departments.

The structure of the plan for the development of educational programs includes sections: analysis of the current situation, development of EP, improvement of EP, improvement of human resources, educational and methodological activities, research activities, creative activities, international activities, educational work, material and technical security.

The individuality of the development of EP 7M02161 Art Management, EP 7M02154 Film and TV directing lies in the fact that the undergraduate designs and carries out his professional, scientific and scientific-pedagogical activities, controls and objectively evaluates the results, owns the methods of self-realization, self-organization.

This ensured the unity of the educational and scientific process - the implementation of scientific research not only at the departments, but also at production bases. Undergraduates conduct research activities at enterprises with which contracts for internships have been concluded.

A highly qualified teaching staff participates in the implementation of accredited programs - teachers of the educational program are researchers in the field of art management, art history, cinema and TV, authors of numerous articles in educational and methodological literature, participants in international scientific conferences, winners of republican competitions and projects (The best teacher of the university, grant funding projects).

At the same time, the problem of insufficient risk management in relation to competition from other universities implementing similar programs, as well as a decrease in interest in the profession and motivation for learning, which had a negative impact on the number of students, was noted.

According to the EEC, thanks to the consistently implemented education quality policy, it was possible to form unique educational programs 7M02161 Art Management and 7M02154 Directing Film and TV, which are developing in accordance with the strategic goals of the university to train competitive specialists based on the integration of education, science and production, which can be in demand both in the national and international labor markets. So the uniqueness of EP 7M02161 Art Management lies in the fact that graduates of the master's program have the skills to organize large-scale projects in the field of art, culture and media; research and development in the field of art management; work in the field of vocational education; conducting expertise in the field of science, art and education. The program takes place in close cooperation with Goldsmiths University (London, UK) and NGO Impact Hub (Almaty, Kazakhstan), which creates a modern educational cluster of international character. The teaching staff of the department use their professional connections with international experts, which resulted in a long-term participation in the British Council program - "Creative Spark" to develop and implement a new discipline - "Creative Entrepreneurship".

Strengths: EP 7M02161 Art Management and EP 7M02154 Film and TV Directing

1. Creation of unique educational programs 7M02161 Art Management and 7M02154 Film and TV Directing, which are developed in accordance with the strategic goals of the university to train competitive specialists based on the integration of education, science and production.

EEC recommendations

- 1. In order to increase the number of students and attract public interest in the educational programs 7M02161 Art Management and 7M02154 Film and TV Directing, strengthen the work on risk management in terms of more actively informing the public about the benefits of the program. Provide open access on the official website and social networks scientific and creative achievements of teachers and students, information about strategic partners and employment prospects. Deadlines 01.07.2022
- 2. Update the quality policy in terms of meeting the needs of the labor market, both at the national level and internationally. Ensure the participation of all interested parties, including foreign partners, in the procedures for assessing the quality of the EP. 07/01/2023
- 3. Develop a system of measures to improve the position of the university in domestic and world rankings of educational organizations. 07/01/2023
- 4. The management of the university and the EP to provide students with the opportunity to obtain double diplomas using distance and mixed educational technologies; to introduce for this purpose an active search for national and foreign partner universities.

Deadline: 07/01/2023

Conclusions of the EEC according to the criteria:

According to the standard "Management of the educational program" EP revealed 15 criteria, of which 1 have strong positions, 13 have satisfactory positions, 1 suggest improvement.

- ✓ The management of the EP must demonstrate the existence of a mechanism for communication with students, employees and other interested parties, as well as mechanisms for resolving conflicts.

Evidence

There is a fairly effective system of information and feedback, which includes: the website of the academy (www.kaznai.edu.kz) and electronic library in T.K. Zhurgenov KazNAA. The system for collecting, analyzing and managing information of educational programs 7M02161 Art management, 7M02154 Film and TV directing (profile direction) is carried out on the basis of the use of modern information and communication technologies and software, for example, the department is equipped with computer workstations and software.

The workflow of departments implementing accredited programs uses the Platonus information system for teaching staff and other participants in the educational process - an automated information system that allows you to comprehensively automate the processes of credit and distance learning systems. The system has a centralized database that reflects all real events and processes of the university. And also - an e-learning and testing system LMS MOODLE. Information is stored on the Academy's servers, in the LMS MOODLE system and is available to all interested persons, departments and structures.

The leadership of the academy, departments, the management of the EP and teaching staff are systematically trained in education management programs that contribute to the development of a high-quality educational process.

The frequency, forms and methods for assessing the management of the educational program and structural units are defined in the following documents:

Analytical part

To assess the quality assurance system of T.K. Zhurgenov KazNAA organizes the collection and analysis of information in the following areas: 1. Development, implementation and use of information systems. 2. Determining the stakeholder requirement. 3. Analysis of the external and internal environment of the university. 4. Internal audits of processes. 5. Conducting an assessment of the satisfaction of stakeholders with the educational services of the university.

The degree of satisfaction with the needs of teaching staff, staff and students within the framework of accredited EPs is determined using questionnaires, surveys at department meetings, in conversations between students and supervisors in the framework of scientific and educational work. Detected deficiencies are recorded in the protocols of the department, the elimination of deficiencies is also reflected in the decisions of the department.

The effectiveness and efficiency of activities in the context of the EP is determined by constant monitoring, which consists of various forms of quality control: the level of progress, students' achievements, student satisfaction with the implementation of the EP and the quality of education in accredited programs are analyzed.

Achievements of undergraduates in the framework of EP 7M02161 Art Management, 7M02154 Film and TV directing are recorded in the reports of departments and faculty, they are reported on the Academic Councils of T.K. Zhurgenov KazNAA. The priority direction of the policy of KazNAA is focusing on consumers: identifying their requirements and assessing the degree of compliance with the established requirements. However, there are problems with the recruitment of applicants, so the Academy should be more active in informing the public about the benefits of the programs.

To support the process of employment of graduates, the Academy organizes an annual Job Fair with the participation of employers. The distribution of graduates is carried out by the commission for the distribution of young specialists. Graduating departments and dean's offices on an ongoing basis ensure communication with graduates and form data on career growth.

Employees and teaching staff and students document their consent to the processing of personal data when drawing up an employment contract.

Teaching staff provide information about their achievements by posting scientific articles, posting personal information on scientific research in the teacher's portfolio in the MOODLE system, participating in the teaching staff rating. Information from students is collected through the rating of students, the rating of study groups and faculties. Based on the information provided by students and teaching staff, various kinds of decisions are made.

Students are regularly surveyed to identify the degree of satisfaction with the quality of educational programs and the conditions for their implementation. Much attention is paid to the organization of consulting work with students, teachers, curators and mentors (advisers), which ensures convenient communication and feedback from all participants in the educational process.

Strengths of EP 7M02161 Art Management and OP 7M02154 Film and TV Directing:

1. The university has formed and operates a mechanism for the systematic use of processed, adequate information to improve the internal quality assurance system. Both students and teaching staff and employees of the university are involved in the processes of collecting and analyzing information. Students are regularly surveyed to identify the degree of satisfaction with the quality of educational programs and the conditions for their implementation. Convenient communication and feedback of all participants in the educational process is provided.

EEC recommendations on EP 7M02161 Art Management and EP 7M02154 Film and TV Directing

- 1. In order to increase the number of students and attract public interest in accredited EPs, strengthen risk management in terms of strengthening the competitiveness of the Academy and more actively informing the public about the benefits of the program.
- 2. Strengthen the collection and provision of information to the general public on key performance indicators of educational programs, in particular, on the creative, scientific and innovative activity of teaching staff and students.
- 3. Create a platform for publishing a portfolio of creative and scientific works of teachers and the entire faculty, as well as creative portfolios of students to increase employers' awareness of the level of professional training and the creative potential of students.

Educational programs 7M02161 Art Management, 7M02154 Directing Film and TV (profile direction) are developed in accordance with the State Educational Standard of Higher Education, approved by the Ministry of Education of the Republic of Kazakhstan dated October 31, 2018 No. 604, in accordance with the National Qualification Framework, professional standards, general demands of society, aligned with the Dublin Descriptors and the European Qualifications Framework. The EPs of this cluster correspond to the mission of the academy, which meets the needs of employers and is based on the academy's regulations.

Graduate model for accredited educational programs 7M02161 Art Management, 7M02154 Film and TV directing is determined by general professional and professional competencies. Upon completion of the EP, students receive a qualification that corresponds to a certain level of the NSC - Master of Arts. The qualifications of graduates are clearly defined and explained in the MEP - a modular educational program and recorded in the documents received by graduates

The order and procedure for the development and approval of the EP are based on the following documents:

- "Guidelines for the design of modular educational programs" (approved on 11/06/2020);
- "Regulations on the organization of the educational process with the use of distance learning technologies in T.K. Zhurgenov Kazakh National Academy of Arts.".

On a regular basis, an analysis of curricula and catalogs of elective disciplines is carried out annually https://cloud.mail.ru/public/PzjD/6i2uzjo1D, class schedules, which allows the entire system of training specialists to function without unjustified risks and shocks.

The participation of employers in the development of the EP, ensuring their quality is confirmed by their signatures in the EP. According to EP 7M02161 Art Management - Director of the LLP "Eurasian Cultural Alliance" Veselova O., Director of the art center "Alen" Alenov E.B. According to EP7M02154 Film and TV directing - Tursunov E. - director, screenwriter, producer, chairman of the Union of Cinematographers of Kazakhstan, Sataev A. - president of JSC "Sh.Aymanova Kazakhfilm" and others.

Analytical part

In the course of the work of the expert commission, conclusions were drawn that the accredited EPs set goals consistent with the mission of the academy, formed taking into account the needs of the labor market of the region, with an emphasis on student-centered learning. The goals of the EP are reviewed taking into account the needs of society, the economy and the labor market.

The implementation of EP 7M02161 Art Management, EP 7M02154 Directing Film and TV (profile direction) is aimed at developing the professional competence of future specialists, which is confirmed by the relevant qualification framework for educational levels in accordance with the National Framework, as well as professional standards for directing "Activity for the production of film videos and television programs" and "Activities for the creation and broadcasting of television programs".

Educational programs of the Academy are developed by supervising departments within groups of educational programs. For the development of the EP, leading teachers, representatives of employers, and students are involved.

Educational programs are developed in the context of a competency-based model of specialist training and are focused on learning outcomes expressed in the form of competencies.

Educational programs are formed according to the modular principle. Each module of the educational program is focused on achieving a certain learning outcome, that is, competence. Learning outcomes are formulated for the program as a whole, for each module and individual discipline.

The procedure for developing educational programs includes:

- 1) Determining the qualification characteristics of a graduate based on the content of the professional standard and / or research on the requirements of employers.
- 2) Establishment of possible educational trajectories within the framework of one program, taking into account the requirements of consumers.
- 3) Determination of the expected learning outcomes in accordance with the Dublin descriptors, the qualification characteristics of the graduate and taking into account the requirements of internal and external stakeholders.

The formation of a catalog of elective disciplines is determined by the relevance of the course, the correspondence of the content to the modern demands of science and technology, the experience and qualifications of the teacher, connection with production, the availability of an experimental and methodological base.

Examination of educational programs is carried out by leading employees or heads of organizations, enterprises corresponding to the profile of training specialists: according to EP 7M02161 Art Management - Director of Contorra Studio LLP T.S Balbaev.

When developing the educational program 7M02161 Art Management, the experience of leading universities, domestic and foreign, with programs of a similar orientation was used. Joint educational programs are being created with foreign educational organizations, while the importance of unique author's methodological approaches is not reduced.

At the same time, it was noted that the educational program 7M02154 Film and TV directing needs a more dynamic modernization of content content. The goals of educational programs should be updated more frequently so that the expected results do not lag behind the needs of a dynamically changing labor market.

Strengths of EP 7M02161 Art Management and OP 7M02154 Film and TV Directing:

- 1. The goals of educational programs are formulated 7M02161 Art management, 7M02154 Film and TV directing, which clearly correspond with the strategic development plan of T.K. Zhurgenov KazNAA and the real demands of the modern domestic and world labor market.
- 2. When developing the educational program 7M02161 Art Management, the experience of leading universities, domestic and foreign, with programs of a similar focus was used, which made it possible to create joint educational programs with foreign educational organizations.

EEC recommendations on EP 7M02161 Art Management and EP 7M02154 Film and TV directing:

1. It is necessary to document in more detail the process of updating and modernizing educational programs in terms of its algorithm, frequency, conditions for involving all stakeholders and taking into account their recommendations, analysis and criteria for evaluating the result. It is necessary to ensure a real update of educational programs and all their components, taking into account the needs of a dynamically changing labor market, the requests of business and production representatives, as well as the opinions of graduates; annually update educational programs in terms of the composition and volume of disciplines established in the curriculum, the content of the work programs of training courses, programs of educational and industrial practices, as well

as assessment materials and methodological resources.

- 2. Develop cooperation with other domestic and foreign universities of a similar nature in order to introduce a system of double diplomas.
- 3. The management of the EP should ensure an interdisciplinary approach in the implementation of the EP, in particular, when setting goals for course projects, professional practices, topics of the WRC, etc.

Evidence

Achieving the goals of EP 7M02161 Art Management, 7M02154 Film and TV Directing and the formation of planned learning outcomes is achieved by constant monitoring and periodic evaluation of educational programs, which allows meeting the needs of students and society.

Since the beginning of 2021, work has begun on updated MEP EP projects in accordance with the competency-based approach, as a factor in improving the quality of higher education. By the beginning of the new academic year 2022-2023, the MEPs for all levels and trajectories of the EP were approved by the decision of the Academic Council of KazNAA.

The method of evaluating educational programs is the expert method. The forms of evaluation of educational programs are external and internal evaluation. External evaluation of educational programs is carried out by an expert group, which includes representatives of employers, faculty and students.

The process of monitoring, evaluating and improving educational programs is the responsibility of the heads of graduating departments and deans of faculties where the EP is implemented.7M02161 Art Management, EP 7M02154 Film and TV Directing, and is controlled by the Department of Academic Activities and the Service for Organization and Monitoring of the Educational Process.

Documentary evidence of changes in educational programs are: decisions of collegiate bodies; action plans to improve the educational program; updated methodological support based on the decisions of collegial bodies; event protocols; annual report on the results of monitoring and evaluation of the educational program.

The interaction of departments with employers is carried out incl. and through the joint formation of a catalog of elective disciplines. Taking into account the interests of employers and

improving the professional training of specialists, it is planned to update the content of the EP annually by introducing new disciplines of the elective component.

During the academic year, students take part in the questionnaire assessment "Teacher through the eyes of students" twice. The results of the survey make it possible to determine the level of criteria for the compliance of teachers with their activities. The results of the survey are considered at the end of the academic year at a meeting of the department.

The expectations of those entering the EP are clarified at the stage of preliminary consultations upon admission, when teachers explain in detail the specifics of the chosen profession and the conditions for studying in it (https://talapker.kaznai.kz/?p=5224) In the event that already during the training, students decide to change the trajectory of education and switch to another specialty, the transfer procedures are regulated by the internal documents of T.K. Zhurgenov KazNAA.

Analytical part

Accredited EP 7M02161 Art Management, EP 7M02154 Film and TV Directing were developed with the participation of employers and taking into account priorities, trends in the art industry, the Concept of the Cultural Policy of Kazakhstan was taken as the basis, disciplines related to the IT competencies of students were included.

When creating the educational program EP 7M02154 Film and TV Directing for 2021-2022, employers took an active part in the discussion of its content: Tursunov E. - director, screenwriter, producer, chairman of the Union of Cinematographers of Kazakhstan, Sataev A. - president of JSC "Kazakhfilm" named after. Sh.Aymanova» and others.

Director of the LLP "Eurasian Cultural Alliance" Veselova O., director of the art center "Alen" Alenov E.B.

The Academy ensures the participation of students, employers and other stakeholders in the evaluation and revision of programs. At the graduating departments that implement accredited educational programs, monitoring and periodic evaluation of EPs are carried out, in which the teaching staff of the department takes part. The monitoring results are aimed at improving the EP. As part of the monitoring, curricula, catalogs of elective disciplines, individual plans for student programs, internal regulations governing the implementation of educational programs, their monitoring and evaluation are analyzed. The workload and academic performance of students comply with the regulatory requirements and state educational standards.

Students are provided with bases of practice. However, they are all located in a limited region. To understand the goals of the profession in an international sense, it is necessary to expand the geography of the bases of industrial practices throughout the country and abroad.

The university has a point-rating system for assessing knowledge, which allows you to objectively, accurately and comprehensively assess the knowledge, skills and qualities of students. Every week, the teacher puts points in an electronic journal on the university website. After reviewing their rating, the student can correct existing problems in a timely manner, since the rating database is closed every two weeks.

Strengths of EP 7M02161 Art Management and EP 7M02154 Film and TV Directing:

1. Competitiveness and development prospects of the EP of the departments "Art Management and Producing" and "Direction of Screen Arts" is implemented through practice-oriented training of students on the basis of practices that are the leading art enterprises in the region. As a result, the implementation of educational projects of students is carried out in the form of full-fledged works of art.

EEC recommendations on EP 7M02161 Art Management and EP 7M02154 Film and TV directing:

1. Expansion of practice bases in all regions of Kazakhstan and abroad, where there

are creative organizations and enterprises whose activities and technological equipment correspond to the content of educational programs 7M02161 Art management, 7M02154 Film and TV directing. Timing

- 2. Develop and put into action a mechanism for informing all stakeholders about the results of monitoring, analytical activities based on monitoring materials, as well as about planned or taken actions regarding the updating and modernization of the EP. Timing
- 3. Develop a system of measures to improve the position of the university in the Russian and world rankings of educational organizations. Strengthen the involvement of employers in participation in professionally oriented events organized by graduating departments. Timing

Academic policy of T.K. Zhurgenov KazNAA is aimed at the implementation of student-centered learning and continuous improvement of the quality of education. Academic policy includes: university admission policy, quality assurance policy, issues of organization of the educational process, organization of training using distance learning technologies, organization of professional practice, issues of assessing students' educational achievements, the procedure for choosing the educational trajectory of students, issues of ECTS and study load, transfer and reinstatement of students at the Academy, granting academic leave, awarding scholarships, academic honesty and time limits.

The issues of student-centered learning are also reflected in the following documents of T.K. Zhurgenov KazNAA:

- -Rules organization of the educational process on credit technology of education;

The formation of individual educational trajectories is carried out on the basis of the Academic Policy and QED, which contains a list of all disciplines of the elective component, indicating the purpose of the study, summary and expected results of the study.

For the development of academic disciplines accredited by EP 7M02161 Art Management, 7M02154 Film and TV directing, there is a sufficient amount of educational and methodological support in the state language: total: 2981 copies, of which educational literature - 2833 copies, educational literature - 25 copies ., scientific fund - 123 copies, provision with educational literature - 29.9%.

Educational trajectory planning (enrollment in disciplines) is carried out in accordance with the academic calendar (<u>Appendix A11 Academic calendar.pdf</u>). The procedure for enrolling in disciplines for the choice of specialties is organized by the department (office) of the registrar in electronic form with methodological and advisory assistance from departments and advisers.

The procedure for enrolling students in the study of disciplines is organized by the Registration Office with the involvement of advisers, departments, deans, the service for organizing and monitoring the educational process, the department of student statistics and analysis.

To provide timely assistance to students in mastering educational programs, the Academy has special structural units, in particular, the Educational Process Organization and Monitoring Service, which consists of such departments as the Student Department, Office Registrar Department, Educational Process Monitoring Department.

The Academy provides the opportunity to freely express one's opinion, criticisms, complaints and suggestions, both orally and in writing in the rector's blog (https://kaznai.kz/ru/blog-rector/) on the official website of the Academy.

To activate student self-government, the readiness of young professionals for independent work and labor activity, the development of an active citizenship, the patriotic education of highly qualified specialists who are able to make independent decisions and actively participate in solving creative, social and economic problems, the Academy has a "Service for Combating Corruption and Issues Youth Policy", which consists of the "Department for Social and Educational Work and Youth Policy" and the "Department for the Formation of Anti-Corruption Culture".

All teachers are practitioners in the respective industrial sector. So, for example, the senior lecturer of the department "Art Management and Producing" PhD Sorokina Yu. It integrates innovative techniques from the practice of artists around the world into the educational process in the classroom for the discipline "Creative Thinking in Art". Undergraduates created an archive of creative tasks on Instagram under the hashtag #creativethinkinginart - this allows not only to accumulate interesting tasks for students, but also to promote the EP among young people.

Analytical part

During the implementation of accredited EP, the most frequently used methods are a problem lecture (involves the formulation of a problem, a problem situation and their subsequent resolution), a seminar – dispute (collective discussion of a problem in order to establish ways of its reliable solution), educational discussion (used in the analysis of problem situations when it is necessary to give a simple and unambiguous answer to a question, while alternative answers are assumed), educational cooperation or group work (students combine their intellectual efforts to complete a common task), "brainstorming" (involves collecting as many ideas as possible, freeing students from the inertia of thinking, overcoming the usual train of thought when solving a task),

didactic or business game (the student must perform actions similar to those that may take place in his professional activity). The following innovative methods are actively used: the method of problem presentation, the method of projects, problem-search methods.

Decisions on the use of innovations in the educational process are made by the teacher himself, developing the EMCD and determining which teaching methods he will use.

The achievement by each student of the goals of the accredited EP is objectively assessed based on the availability of a feedback system for the use of various teaching methods and evaluation of learning outcomes. The curricula for the areas of training take into account such important components as progression and improvement of knowledge from course to course, focused on the competencies of students.

Individual plans of undergraduates are focused on the unique approach to each student, where support for the autonomy of students is tangibly expressed with simultaneous guidance and assistance from the teacher. So, for example, undergraduates are prepared for subject Olympiads, competitions and festivals, comments are written on independent work, questions are being finalized on lectures according to the SROP schedule, communication is maintained by e-mail with each undergraduate.

The student receives information about the current grading system at the university in the first year during meetings with the dean, head of the graduating department, curator (advisor). The main provisions of knowledge assessment are presented in the Academic Policy.

Transparency of criteria and tools for assessing knowledge is achieved through:

- familiarization of students with the applied criteria for assessing knowledge and the requirements for studying the discipline in accordance with the syllabus, the modular (working) curriculum of the discipline in the first lesson;
- the availability of assessment criteria for students (in syllabuses and EMCD, posted in the electronic library).

A student who does not agree with the results of the examination assessment has the right to appeal. The procedure for granting the right to take a session individually is defined in the Academic Policy.

The university ensures full transparency of the results of knowledge assessment. The results of the current and midterm control, as well as intermediate certification are available to students on the MOODLE educational portal. There is a mobile version of the MOODLE portal, which allows students to quickly view all information from mobile devices.

The student can form his own individual curriculum with fewer credits than established for the development of the educational program of the corresponding level, while increasing the duration of training.

The teaching methods used by teachers are based on knowledge of the principles of higher education pedagogy, which are systematically supported by practical seminars currently held at the academy in an online format. Their effectiveness is due to the fact that all teachers are professional practitioners.

Strengths of EP 7M02161 Art Management and EP 7M02154 Film and TV Directing:

- 1. Students are given the opportunity to study individual disciplines or modules in other educational institutions, including abroad.
- 2. Teachers use advanced educational methods aimed at the comprehensive development of knowledge, skills and abilities by students in each individual discipline, and in general along the entire trajectory of the training direction. The main reserve of teaching methods for accredited programs is the professional activity of teaching staff, since all teachers are constantly engaged in creative work.

EEC recommendations on EP 7M02161 Art Management and EP 7M02154 Film and TV directing:

1. Using human and methodological resources, to provide students with the opportunity to

receive education in their chosen language - state or foreign, even when it comes to isolated cases.

- 2. Shift the focus to the research work of students, develop and implement motivational tools to enhance publication activities, involve them more fully in the research and innovation work of the teaching staff, and stimulate their interest in entering doctoral studies.
- 3. Develop a well-defined and effective algorithm for the appeals procedure and make this information open and accessible to students.

Deadline: 01.12.2022

Conclusions of the EEC according to the criteria:

According to the standard "Student-Centered Learning, Teaching and Assessment" EP 7M02161 Art Management and EP 7M02154 Film and TV Directing disclosed 10 criteria, of which 2 have strong, 8 satisfactory positions, 0 - suggests improvement.

6.6. Standard "Students"

- ✓ The EI must demonstrate the existence of a policy for the formation of a contingent of students in the context of the EP, ensure transparency and publicity of its procedures governing the life cycle of students (from admission to completion).
- ✓ The management of the EP should determine the procedure for the formation of a contingent of students based on:
 - minimum requirements for applicants;
 - the maximum size of the group during seminars, practical, laboratory and studio classes;
 - predicting the number of government grants;
 - analysis of available material, technical, information resources, human resources;
 - analysis of potential social conditions for students, incl. provision of places in the hostel.

Evidence

The policy of forming a contingent of students at the academy is to admit people to the number of students who are the most prepared for training in air defense, who have scored the required number of points based on the results of CT and entrance creative exams and only on a paid basis.

The draft plan for the admission of students for the next academic year is considered and discussed at meetings of departments, EMBF, AC and approved by order of the Rector of the Academy. Career guidance work is of a planned nature and includes informing students of OPGE about KazNAA EP, its competitive advantages, and the demand for graduates in the labor market; holding advertising campaigns within the framework of Open Doors Days, field meetings with students of OPGE; holding subject Olympiads, conferences, round tables, competitions and exhibitions at the Academy; placement of information in the media; timely correction of Internet information about the Academy on the official website of KazNAA.

In order to strengthen career guidance, reach a new level of public relations, the Academy's interaction with interested bodies and institutions, prompt study and forecasting of the need for specialists in the educational services market and further improve the image of KazNAA, the

departments and OPGE present the information necessary for future applicants in the section "Applicants" on the KazNAA website. The faculties and the Department of Career Guidance, together with the Department of Air Defense of the Academy, develop promotional products and coordinate the activities of the faculties in working with potential applicants and employers. The promotional products contain clearly developed criteria that are accessible to applicants, transparent, describing the conditions of study, the opportunities that the EP provides, as well as future employment opportunities.

The policy of forming a contingent of undergraduates from admission to graduation is ensured by the transparency of procedures that regulate the life cycle of students (from admission to completion). Thus, the rules that govern all periods of study have been developed and approved, and are also available for study on the website. Admission and admission to study at accredited EPs takes place in accordance with <u>Rules</u> on admission to the master's and PhD doctoral studies, approved by the Academic Council of T.K. Zhurgenov KazNAA on May 28, 2020, protocol No. 10.

The rules that govern all periods of study are developed and approved in the document "Academic policy of T.K. Zhurgenov Kazakh National Academy of Arts", approved by the Academic Council of the RSU "Kazakh National Academy of Arts named after T.K. Zhurgenov" MCS RK dated August 27, 2020 No. 1, and are also available for study on the website https://kaznai.kz/normativnye-akty-2/.

Social conditions for undergraduates are under constant control of the management of the EP.

The procedure for recognizing previous learning outcomes and competencies mastered in the framework of academic mobility, as well as additional, formal and non-formal training, is regulated by the provisions approved by the Academic Council of T.K. Zhurgenov KazNAA (Rules organization of the educational process on credit technology of education; Confession learning outcomes of formal and non-formal education).

The most important part of the system of training highly qualified specialists is the student's research work as a complementary part of the educational process. The research work of the student is carried out in accordance with <u>Regulation</u> on the organization of research work, as well as with the annually approved thematic plans of the departments.

Analytical part

Accredited EPs are based on defined and consistently applied rules that govern all periods of study, including admission, performance, recognition and certification.

The accredited EPs have a defined procedure for the formation of a contingent of students. So, for admission to the EP 7M02161 Art Management / 7M02154 Film and TV Directing, requirements for applicants have been developed and approved.

Determining the professional orientation and professional qualities of applicants is a key aspect of the policy of forming a contingent for all specialties of T.K. Zhurgenov KazNAA. To implement a systematic policy of forming a contingent of students of T.K. Zhurgenov KazNAA a set of measures is being taken to ensure the image of the university as a whole.

The Academy has a model for the formation of a contingent of students, based on the principle of electiveness by applicants and students of the specialty and form of education.

The need for specialists in the field of directing and art management is being studied through a survey of employing institutions. The formation of the contingent of students is also due to the available material, technical and information resources, as well as the human resources of the departments "Direction of screen arts", "Art management and production". Thus, the departments have specialized studio premises, editing and photo and film pavilions, the area of which, per each student, is about 2.5 m rules "Sanitary and epidemiological requirements for educational facilities".

The staff in the areas of training film and TV directors is represented by practitioners with extensive experience in creative work, who have declared themselves in the professional field of art, being people's artists, honored workers of the Republic of Kazakhstan, awarded medals and

Certificates of Honor of the Republic of Kazakhstan: Azimov S.M., Abildina G.B., Manabay D.K., Kalymbetov B.N., Lavrik N.A., Baigozhina A.M. and etc.

Social conditions for students are under constant control of the management of the EP. The provision of places in the hostel takes place in accordance with the "Regulations on student hostels of the RSI "T.K. Zhurgenov Kazakh National Academy of Arts" at the request of the students. Places are distributed by a commission at the faculty, which includes: dean, deputy dean, representative of the student trade union committee, student council of the faculty. And then a specially created commission consisting of the vice-rector for educational work, the chairman of the trade union committee of the academy, the head of the YAC,(Committee for Youth Affairs) the chairman of the student trade union committee. Group curators regularly visit their wards in the hostel.

EP 7M02154 "Film and TV directing" (profile direction), being part of the educational process as a whole in KazNAA. In order to ensure comparable recognition of qualifications, T.K. Zhurgenov KazNAA cooperates with other educational organizations and national centers of the "European Network of National Information Centers for Academic Recognition and Mobility / National Academic Recognition Information Centers" ENIC / NARIC. Thus, the Academy entered into an agreement with the University of Applied Arts in Oolu (Finland) on academic mobility (https://kaznai.kz/ru).

Recognition of the results of academic mobility of students, as well as the results of additional training, is due to the rules and documents of T.K. Zhurgenov KazNAA. The possibility for external and internal mobility of students in the EP is regulated by the "Regulations of T. Zhurgenov KazNAA on academic mobility". Assistance in obtaining external grants for training is provided by the international department of T.K. Zhurgenov KazNAA, collecting up-to-date data and notifying students.

All students in the EP are provided with places for all types of practices stated in the working curricula of the departments. All types of practices are directly related to the acquisition of specialties by students. So, for example, directors undergo internships at JSC "Kazakhfilm named after. Sh. Aimanova", JSC "Khabar", RTRK "Kazakhstan".

As a self-governing body in the academy, the Committee for Youth Affairs (YAC) operates, which has a Charter and Regulations approved by the Academic Council of T.K. Zhurgenov KazNAA. YAC assists students in solving educational, social and other issues; relationships with peers, teachers, the leadership of the academy are also included in the scope of activities of the YAC.

The current EP Alumni Association contributes to the establishment of links between the Screen Arts Directing Department and cultural and art organizations in which graduates work. The department maintains contacts with the television and radio complex "Kazakhstan", JSC "Kazakhfilm named after Sh. Aimanov", Media Center in Astana. Thus, graduates are the stakeholders of educational programs.

At the same time, the EEC noted the inefficient occupancy of study groups, which is due to low interest in accredited educational programs.

Strengths of EP 7M02161 Art Management and EP 7M02154 Film and TV Directing.

- 1.T.K. Zhurgenov KazNAA, the transparency of procedures for the formation of a contingent of students is ensured, which is determined by the need for specialists in the field of directing and art management. The formation of the contingent of students is also due to the available material, technical and information resources, as well as the personnel potential of the graduating departments "Direction of screen arts", "Art management and production".
- 2. Employment and professional activities of graduates of the EP EP 7M02154 "Film and TV directing" (profile direction) are regularly monitored, which is under constant control of the Screen Arts Directing department and the department of career guidance and educational and industrial practice.

- 3. The Alumni Association has been established and is actively functioning at the academy.
- 4. The mechanism of material and non-material support of gifted students functions in the university.

EEC recommendations on EP 7M02161 Art Management and EP 7M02154 Film and TV directing:

- 1. Strengthen career guidance activities to attract domestic and foreign applicants. For this purpose, create commercials about the benefits of the programs implemented at the Academy. Use the help of alumni employers for promotional purposes.
- 2. It is necessary to develop and effectively implement special adaptation and support programs for newly enrolled and foreign students.
- 3. Through interaction with the municipal authorities, solve the transport problems of students living in the hostel.

Conclusions of the EEC according to the criteria:

According to the standard "Students" EP 7M02161 Art Management and EP 7M02154 Film and TV Directing disclosed 12 criteria, of which 10 have satisfactory positions, 2 suggest improvement.

6.7. Standard "Teaching Staff"

- ✓ The EI must have an objective and transparent personnel policy, including in the context of the EP, including recruitment, professional growth and development of personnel, ensuring the professional competence of the entire staff.
- ✓ The EI must demonstrate the compliance of the staff potential of the teaching staff with the specifics of the EP.
- ✓ The management of the EP must demonstrate awareness of responsibility for its employees and provide favorable working conditions for them.
- ✓ The management of the EP should demonstrate the change in the role of the teacher in connection with the transition to student-centered learning.

Evidence

An objective and transparent personnel policy is provided, including recruitment, professional growth and development of personnel, ensuring the professional competence of the entire staff in. T.K. Zhurgenov KazNAA. <u>HR policy</u> The Academy was approved by the decision of the Academic Council of the Academy of August 29, 2018, protocol No. 1.

When hiring teaching staff, the criteria are applied in accordance with Appendix No. 1 "Qualification requirements for positions of the teaching staff" to Regulations on the competitive replacement of teaching staff positions of T.K. Zhurgenov KazNAA, approved by the decision of the Academic Council in February 27, 2020 (Minutes No. 7). Appointment, promotion is also carried out in accordance with this Regulation.

The transparency of personnel procedures is observed as follows: when a competition is announced for filling vacant positions of teaching staff, the announcement is placed in republican periodicals or on Internet resources. For teaching staff, the head of the personnel documentation

and accounting service annually holds a seminar to explain all the basic qualification requirements necessary for participation in the competition. And also the secretary of the competition commission acquaints all participants of the competition with the decision of the competition commission.

Also, all other personnel procedures are prescribed in <u>Instructions</u> on personnel records management, approved by order of the rector of the Academy dated March 09, 2017 No. 01 / 04-58P, this instruction is posted on the Academy website.

Qualification characteristics of the positions of pedagogical workers and persons equated to them RSI "T.K. Zhurgenov Kazakh National Academy of Arts" MCS RK were developed in accordance with the Law of the Republic of Kazakhstan dated July 27, 2007 No. 319-III "On Education", Standard qualification characteristics of the positions of pedagogical workers and persons equated to them, approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated July 13, 2009 No. 338, National Qualifications Framework approved protocol dated March 16, 2016 by the Republican tripartite commission on social partnership and regulation of social and labor relations and The professional standard "Teacher", approved by-order-Chairman of the Board of the National Chamber of Entrepreneurs of the Republic of Kazakhstan "Atameken"No. 133 dated June 8, 2017.

A favorable atmosphere has been created at the departments and at the Academy as a whole for increasing professional competence, expanding professional knowledge and skills. Teaching of the teaching staff of the university in advanced training courses is carried out on the basis of other universities, as well as in specialized training centers of the Republic of Kazakhstan. Certificates and certificates of advanced training of teaching staff are placed in the personal files of employees.

The advanced training of teaching staff also takes place in the form of participation in scientific and methodological seminars, conferences, exhibitions and other events, training in magistracy, doctoral studies.

Information about the teaching staff for accredited programs is posted on the Academy's website, which displays both general information about the number of faculty members and personal portfolios of the teaching staff.

The teaching staff of the Academy fully meet the indicators of personnel policy.

Staff composition of EP 7M02154 Directing Film and TV: The total number of teachers of the department as of 03/01/2022 is 26 (full-time - 23) people, including: 9 - candidates of science, 3 - PhD, 12 - masters.

Analytical part

As a result of working with the documents presented on the website of the academy, studying the self-assessment report and direct communication with the teaching staff in the form of an interview, the EEC concluded that there is a high potential for staffing accredited programs. All teaching staff involved in the implementation of programs fully comply with the indicators of the personnel policy, as well as the requirements of the standard.

As of February 18, 2022, the Department of Art Management and Producing, which is engaged in the training of specialists in EP 7M02161 Art Management, currently employs only 8 people, of which 100% are full-time teachers. The degree of the total number of teaching staff for EP is 66.6%. The educational process under the program is provided by a highly qualified teaching staff, including 4 candidates of economic sciences (Moldasheva A.K., Klimova T.G., Musabaev K.M., Musaeva A.A.), 1 doctor of PhD (Sorokina Yu. V.), 1 professor (Baybekov A.), 3 masters (Kumarova A., Tokpan A., Dzhumadilova Zh.). 3 teachers out of 8 who have a PhD degree and published articles in peer-reviewed journals have the opportunity to teach in the magistracy and be supervisors of master's theses.

All teachers have a higher education in their specialty and practical work experience in the relevant direction. Of the 8 teachers of the department "Art Management and Producing" 4 candidates of economic sciences in the direction 08.00.05 - Economics and management of the national economy (by industry and field of activity) - Moldasheva A.K., Klimova T.G., Musabaev K.M. ., Musaeva A.A., including 2 associate professors (Moldasheva A.K., Klimova T.G.), 1 PhD in art history - Sorokina Yu.V., 2 masters of arts - Kumarova A., Tokpan A.

It is a good practice that foreign scientists are invited to give lectures. On the basis of the agreement, Candidate of Economics, Associate Professor Umarov A.S., Senior Lecturer Kodirov K.R. National Institute of Arts and Design named after K. Behzod held a lecture on the topic "Gallery business in Uzbekistan"; teacher Khudaibergenova N.T. - on the topic "Taxation in the Republic of Uzbekistan".

In order to support young teachers, work is underway to create a reserve of personnel, material support is provided for scientific research and internships.

The establishment of long-term labor relations with each employee, based on compliance with the requirements of the Labor Code of the Republic of Kazakhstan, allows the employee to fully realize the existing level of professional competence, as well as improve it with the needs of the Academy and the requirements of the level of job competence of the employee.

All representatives of the teaching staff involved in the educational process successfully combine pedagogical activities with the author's creative practice at specialized enterprises, which provides them with a deep understanding of modern production realities and broadcast it to students.

At the same time, the EEC noted the insufficient level of scientific publication, innovation and grant activity of the teaching staff.

Strengths of EP 7M02161 Art Management and EP 7M02154 Film and TV Directing.

- 1. Accredited educational programs are implemented by highly professional teaching staff, which gives grounds to talk about the creation of a strong school with a scientific, creative and methodological base.
- 2. T.K. Zhurgenov KazNAA develops transparent and objective criteria for hiring employees, appointments, filling vacancies, promotions, dismissals and follows them in her activities in accordance with the principle of meritocracy.
- 3. The personnel potential of the graduating departments "Art Management and Producing" and "Direction of Screen Arts" is able to ensure the strategic development of educational programs of the specialties in question.

EECrecommendations on EP 7M02161 Art Management and EP 7M02154 Film and TV directing:

- 1. To improve the quality of the scientific activity of the university by attracting undergraduates to research activities, expanding the grant and innovation activities of teaching staff, developing partnerships with foreign universities in terms of joint scientific work, increasing the publication activity of teaching staff, including in peer-reviewed publications from the scientometric database Scopus, Web of Science, etc. To intensify the grant and innovation activities of teaching staff involved in the implementation of accredited EPs. Formation of partnerships with foreign universities in terms of the implementation of joint grant programs.
- 2. Expansion of educational practices and technologies through the formation of the teaching staff with the active involvement of specialists with experience in other universities, including foreign ones.
- 3. Development and implementation of a development program for academic mobility of teaching staff through partnership with domestic and foreign universities that have programs with a similar focus. Expansion of the practice of participation of teachers in joint international projects and foreign internships in order to update the content of educational programs.

- ✓ The EI must guarantee a sufficient number of educational resources and student support services to ensure the achievement of the goal of the EP.
- ✓ The EI must demonstrate the sufficiency of material and technical resources and infrastructure, taking into account the needs of various groups of students in the context of the EP (adults, employed, foreign students, as well as students with disabilities).
- ✓ The management of the EP should demonstrate the existence of procedures for supporting various groups of students, including information and counseling.

- ✓ The EI demonstrates the planning of providing the EP with educational equipment and software similar to those used in the relevant sectors of the economy.

Evidence

The Commission (EEC) generally notes that the management of the EP creates favorable conditions in the framework of providing the necessary basis for the implementation of the educational process within the framework of the accredited programs 7M02161 Art Management and 7M02154 Film and TV Directing.

The useful study area, owned by the Academy on the right of economic management, meets the requirements of fire safety, qualification requirements for the activities of educational organizations and the requirements of state general educational standards, implemented specialties.

Both educational buildings are provided with both wired high-speed LAN-Internet and Wi-Fi. Students receive information about the ways to access the Internet (login and password) in the library. Also, students outside of class time have access to work on personal computers installed in the library halls, where they can work on assignments for independent work and search for information to implement their creative projects.

The internal network of the Academy is connected to the scientific resources Web of Science and Web of Knowledge, which allows students to search for the latest scientific data in the works of foreign researchers. Academic support for students is provided by: admission committee, student department, registrar's office, practice and employment department, call centers, library (http://elib.kaznai.kz/).

Support for students at the Academy is also carried out by ensuring public order and the protection of educational buildings and dormitories of the university, ensuring the safety of the material base, the functioning of catering points in educational buildings. The university has a civil defense headquarters, an engineer for safety and labor protection, and there is a permit regime.

Identification of the need for support of various groups and categories of students at the Academy is carried out primarily through the institution of curatorship. After identifying the needs, the advisor directs students to apply to certain departments and services (department, dean's office, registrar's office, psychological counseling office, department of educational work).

Students are supported by advisors, whose main task is to organize educational work with students, promote student self-government and involve students in the socially significant and creative life of the university, promote professional self-determination and professional adaptation of students at the final stage of their studies at the Academy.

During the work of the EEC, it was confirmed that T.K. Zhurgenov KazNAA ensures the availability of sufficient, accessible and appropriate educational resources and student support services. When distributing, planning and providing educational resources, the Academy takes into account the needs of various groups of students.

The Academy effectively operates various student support services (academic support, social support, technical support, material support), which are characterized by availability and demand. Material assistance is provided to needy students: benefits, scholarships, grants, targeted financial assistance.

In the process of interviews with students, the fact was confirmed that nonresident students are provided with accommodation in a hostel. Accommodation in a hostel is carried out in accordance with the Rules for living in a hostel, in compliance with established sanitary standards. The dormitories provided by the Academy are equipped with all the necessary social infrastructure for organizing the life of students and the diversified development of students. However, it turned out that those living in the hostel have serious transport problems, which causes frequent lateness to classes.

To organize the independent work of students, the university forms and maintains an Electronic Library http://elib.kaznai.kz/, containing the methodological developments of university teachers (educational and methodological complex of disciplines, videos, electronic textbooks, electronic publications), high-demand literature, literature for multilingual education. Remote access to the resources of the Digital Library is provided around the clock and can be carried out through local and global networks.

Students of EP 7M02161 Art management have access to cloud storage kaznai-art@mail.ru, which contains video lectures, videos of online events of the department and other useful information. On the MOODLE portal, each teacher uploaded a portfolio with information about his achievements in the field of science, education and social work. And also for each discipline, syllabuses, EMCD, assignments for midterm control, final certification, presentations for lectures, assignments for SIW and SIWT are loaded.

The laboratory fund is equipped with professional equipment that corresponds to modern production realities and is able to provide conditions for the creation of artistic products within the framework of educational, creative and project assignments.

When studying syllabuses in the disciplines of accredited EPs, the presence of outdated literature in some disciplines and the insufficiency of literature in the native language were revealed.

It is also necessary to find opportunities for updating and replacing outdated equipment of educational and creative laboratories, taking into account the specifics of the EP, its subject area, which is associated with a constant qualitative change in equipment and technologies.

The site is maintained in three languages, with identical information presented in all languages. However, it was found that the content of the site in Russian and English is very limited compared to the state language.

Thus, the Instagram channel of the Department of Art Management and Producing @art.management_kaznai is actively functioning, which posts information on entrance exams, ongoing events, publishes creative projects and theses of students in order to inform the general public and stimulate the creative growth of students. Also on the basis of Instagram in personal messages Direct there is direct contact between applicants and teachers of the department, as well as possible partners.

All information posted on the department page on the social network Instagram is automatically duplicated on the page on the social network Facebook - art_management_kaznai. However, as experience has shown, the social network Instagram is a more effective channel for communicating with applicants. EP 7M02161 Art management students have access to cloud storage kaznai-art@mail.ru, which contains video lectures, videos of online events of the department and other useful information. EEC was able to make sure that the information on the website and in social networks is relevant, in demand and constantly updated.
